## The American Rescue Plan Act (ARPA)

The ARPA is a \$1.9 trillion economic stimulus bill passed and signed into law on March 11, 2021. Its purpose is to speed up the U.S.' recovery from the economic and health effects due to the COVID-19 pandemic and the ongoing recession.

The Plan provides direct relief to working families by -

- Providing \$1,400 per person checks to single family making less than \$75,000; Head of Household making less than \$112,500; and married families making less than \$150,000.
- Increasing the Child Tax Credit, Earned-Income Tax Credit and Child and Dependent Care Tax Credit. How it works:
  - For those without children, the Earned-Income Tax Credit will be increased from \$543 to \$1,502;
  - Those with children, increase the Child Tax Credit from \$2,000 to \$3,000 per child for ages 6 and over and \$3,600 for under 6 and raise the age limit from 16 to 17;
- Extend the unemployment insurance until September 6 with a weekly supplemental benefit of \$300 on top of the regular \$400 benefit;
- Small business support provides emergency grants, lending, and investment to hard-hit small businesses; and
- Lower health insurance premiums and provide 100% federal COBRA subsidy through September 1 to ensure those who lose their jobs or have reduced hours don't lose their health care benefits.

In Maine, the ARPA funds are based on a formula grant application process requiring registration of your organization and submitting an application through the grant portal <https://www.grantinterface.com/Home/Logon?url=MSL>. Applications are due by 11:45 p.m. on September 17, 2021.

# News from Around the State—



**City of Biddeford** – The City was awarded a \$1.2 million grant from the U.S. Economic Development Administration (EDA) under the Public Works Program to assist with the construction of roadway and utility improvements on Pearl Street. The EDA funding supports the economic revitalization of Biddeford’s Downtown Mill District by providing improved access to the city’s new parking garage and surrounding buildings. The project includes the reconstruction of approximately 900 l.f. of Pearl Street from the Lincoln Street intersection to the Saco River and Biddeford Riverwalk, including traffic calming bump outs, parallel parking space, pedestrian-friendly sidewalk, storm drainage, underground conduit for electric, telecommunications and internet lines and upgrading of approximately 465 l.f. of sewer lines.



**Town of Fort Fairfield** – The Fort Fairfield Utility District received four bids for the construction of Fort Fairfield’s Wastewater Treatment Facility. The \$12.6 million project will be funded with grants and loans from the Community Development Block Grant (CDBG) Program, Northern Border Regional Commission (NBRC), Clean Water State Revolving Fund (CWSRF), U.S. Economic Development Administration (EDA), Maine Department of Environmental Protection (MDEP), USDA Rural Development and the Fort Fairfield Utility District. The project includes the construction of a new wastewater treatment facility, upgrades to two pump stations, access roads, and other associated improvements. The new facility replaces an aging and severely malfunctioning system constructed in the 1960s.



**City of Bangor** – The City of Bangor and the Bangor Water Department awarded Eastwood Contractors Inc. of Brewer the \$1.7 million contract for the State and Hancock Streets Utility Improvements Project. The project scope includes approximately 1,000 l.f. of new sewer main along Hancock Street and approximately 300 l.f. of new sewer main on State Street. The project also includes approximately 1,245 l.f. of new water main, hydrants, and all appurtenances on State Street from Howard Street to Spruce Street.



**City of Lewiston** – Lewiston’s Tree Streets neighborhood is a working-class area that will get a transformational makeover with a \$30 million federal grant that is expected to leverage \$100 million in other development money. Lewiston has had a surge of downtown development in the past few years but has not reached some of Maine’s most distressed housing stock and poorest residents. Lewiston’s Tree Streets Neighborhood includes apartments owned by the Lewiston Housing Authority that some consider as “one step up from homelessness”. A federal Choice Neighborhoods Implementation Grant from the U.S. Department of Housing and Urban Development in 2018 paid for research and study of replacing the lead-contaminated crumbling housing. Over the next few years, 185 new housing units will be built in one of the state’s poorest neighborhoods.



**Town of Madawaska** – The Town of Madawaska was awarded a \$300,000 Community Development Block Grant (CDBG) grant to continue working on its Downtown Revitalization Plan. The 2021 CDBG award will be matched with the Town’s bond funds to demolish a retaining wall and building, site improvements (parking lot and access road), and utility upgrades (storm drainage, electrical, and water/sewer) at the former Kmart Plaza to accommodate the construction of a new state-of-the art health center. The Town is currently implementing a Façade Improvement Project on Main Street, a recreational trail development system, and is working with the Maine Department of Transportation on the international bridge replacement and new port of entry project.

## Funding Opportunities

### USDA Programs:

- **Rural Business Development Grant (RBDG)**: This program is designed to provide technical assistance and training for small businesses. Small means that the business has fewer than 50 new workers and less than \$1 million in gross revenues. Transportation System applications are due June 30 and Coastal Areas Impacted by Wildfires applications due July 6.

- **Rural Economic Development Loan & Grant Program**: The program provides funding for rural projects through local utility organizations. For more information, contact your local RD Office at [www.rd.usda.gov/me](http://www.rd.usda.gov/me).

- **Strategic Economic and Community Development:** Funding for this program is authorized through a Farm Bill provision that supports regional economic and community development planning. - **Community Facilities Direct Loan and Grant Program:** This program provides affordable funding to develop community facilities in rural areas. An essential community facility is defined as a facility that provides an essential service to the local community for the orderly development of the community in a primarily rural area and does not include private, commercial or business undertakings.

**Maine Community Foundation Programs:**

- **Community Broadband:** The goal is to increase the number of Maine people, communities, and businesses that have access to high-speed internet service and the skills, opportunities, and knowledge to use this technology effectively. Maximum Award is \$15,000 and Application Deadline is August 2.
- **Conservation for All:** The program invests in organizations and projects that build strong connections between people in Maine and our land and water. Maximum Award is \$15,000 and Application Deadline is August 2.
- **Downeast Innovation Fund:** The Downeast Innovation supports nonprofit organizations that provide programs to support or increase entrepreneurship and innovation in Hancock and Washington Counties in Maine. Maximum Award is \$10,000 and Application Deadline is October 15.
- **The Leary Firefighters Foundation:** Jeremiah Lucey Grant Program funds equipment, education, training, and technology for firefighters nationwide. Grants range from \$5,000 to \$25,000. Letters of Inquiry are due August 15 and applications are accepted until October 1, 2021.
- **TD Bank Group: TD Ready Challenge:** The grant program provides support to nonprofit organizations that develop innovative, impactful, and measurable solutions for a changing world. The 2021 theme focuses on addressing predicted learning loss in math and reading for disproportionately impacted students in Grades K-12 as a result of COVID-19. Grants range from \$325,000 to \$1 million and application deadline is August 26, 2021.
- **Medline Community Impact Grant Program:** The program supports nonprofit

organizations that address prevalent health challenges, stimulate health equity and improve population health in under-resourced areas. Grants up to \$25,000 are available and the application deadline is August 27, 2021.

- **USDA Rural Innovative Stronger Economy (RISE):** The program offers grant assistance to create and augment high-wage jobs, accelerate the formation of new businesses, support industry clusters, and maximize the use of local productive assets in eligible low-income rural areas.
- **2021 Regional Forest Economy Partnership Program:** The Northern Border Regional Commission (NBRC) released a press release announcing the 2021 Regional Forest Economy Partnership Program seeking applications for projects supporting forest-based businesses and research. The maximum award size is \$1 million and the minimum is \$250,000. Applicants have until September 10, 2021 to submit a Letter of Interest and applications (by invitation only) are due November 12. ## ***State and Local Fiscal Recovery Funds***

LD 1733 – An Act to Provide Allocations for the Distribution of State Fiscal Recovery Funds is an emergency bill presented by Senator Breen of Cumberland. The bill dated June 3, 2021 is part of the ARPA distribution to states in response to the public health emergency caused by COVID-19 and to its negative economic effects. The \$983 million in federal funds sent to Maine through the American Rescue Plan Act will be used to make investments in workforce development, child care, health care, and infrastructure. The funding plan includes:

- Expanding access to child care and public preschool by creating a \$10 million grant program for child care providers to support efforts to renovate, expand or build new child care facilities to increase access to quality, affordable child care in Maine. The bill would also create a \$10 million grant program to expand the number of public Pre-K programs throughout the state.
- Opening up new economic recovery grants will have access to \$20 million to support businesses and organizations still struggling to rebound from the economic hardships caused by the COVID-19 pandemic. The goal is to ensure no small business or organization falls through the gaps.
- LD 1733 establishes a new program within the Maine Bureau of Insurance to help small business owners afford small group health insurance as their business recovers from financial setbacks caused by the pandemic.
- An investment of \$21 million for the expansion of affordable broadband, with a focus on historically disadvantaged areas and populations will be provided to the Maine Connectivity Authority.

## ***The Revitalization of Maine's Paper Industry***

LD 1713 – An Act to Increase Workforce Skills for the Revitalization of Maine's Paper Industry through the Establishment of an Income Tax Credit for Paper Manufacturing Workforce Training would provide a tax credit to companies like Twin Rivers in Madawaska that maintain good-paying jobs and make significant capital investments to acquire, modernize or improve machinery before January 1, 2024 becomes law. The credit applies to companies that are not eligible for the New Market Tax Credit programs that currently exist.

The well-attended festival included activities such as a BBQ Cook Off, Corn Hole Tournament, Town-wide Yard Sale, Maine Potato Queens, a parade of 100+ entries, and many more and ended with ***Fireworks on Sunday Night***.

The 43<sup>rd</sup> Acadian Festival is scheduled for August 12-15 in Madawaska. Activities will include charlemagne tournament, merchant sidewalk sale, art expo, various contests, music and fireworks. RECOVERY HOUSING PLAN**

The Maine State Housing Authority is drafting a Recovery Housing Plan (RHP) and encourages citizens to comment.

The U.S. Department of Housing and Urban Development (HUD) requires the State of Maine to publish a Recovery Housing Plan. The Plan outlines the use of the HUD Recovery Housing funds in the state. This program was allocated \$951,000 of FY 2020 funding. The RHP is authorized under Section 8071 of the SUPPORT for Patients and Communities Act and is a pilot program.

## *On This Date in History –*



The scale for the Solar system model is one mile on Route 1 To the astronomical unit (AU), which is The distance of that planet from the sun.
