

CARES Act of 2020

The Coronavirus Aid, Relief & Economic Security (CARES) Act is a financial stimulus package designed to help the economy recover from the coronavirus pandemic. The Act is a \$2 trillion package with distribution to the following sectors:



Highlights of the Stimulus Package:

- Cash Payments of \$1,200 for earnings of less than \$75,000; increases by an additional \$500 for married couples and families
- Provides \$600/week of top of base amount a worker receives
- Emergency grants of up to \$10,000 to cover immediate operating costs for small businesses
- Foregiveable loans for small businesses (500 or fewer employees) to maintain payroll, keep workers on the books or pay rent, mortgage and existing debt could be forgiven provided workers stay employed through the end of June.
- Provides relief from existing SBA loan payments for up to six months
- Provides airlines with \$58 billion to help cover employee wages, salaries, and benefits for passenger and cargo carriers and airline contractors
- Provides financial assistance to state and local government for specific COVID-19 response efforts

AFFORDABLE HOUSING NEWS

MaineHousing has awarded \$14.5 million of the senior housing bond approved by nearly 70% of Maine voters in 2015. The bond, combined with MaineHousing resources and other funds, will generate over \$45.8 million to build 212 new affordable housing units for citizens aged 55 and older. The bond funds also included \$500,000 allocated to home repair and weatherization services for existing homes. Seven development projects were selected:

U.S. Housing and Urban Developments' Public Housing Capital Fund Program -Nineteen Maine housing authorities throughout Maine will receive a total of \$9.5 million through HUD's Public Housing Capital Fund Program. The money will help municipal agencies preserve and modernize homes and meet the needs of individuals and families who live in them. The funding will be allocated as follows:

HUD provides grants to public housing authorities annually for the development, financing and modernization of public housing properties and for management improvement.

News from Around the State:

The Towns of Monson, Skowhegan, and Lisbon will each get \$70,000 in grants from the National Maine Street Center Program. These towns were chosen through a competitive application process that is managed by the Maine Community Foundation. The towns will be provided with workshops and training to help build an environment of entrepreneurial to start and grow businesses. They will also receive a planning grant and implementation grants of up to \$25,000 in 2020 and 2021. Congratulations!

Town of Ashland - In an effort to ensure the well-being of the older population and those in need in Ashland, first responders have taken it upon themselves to check in with those at risk in the community. Rather than go door-to-door, they formed a "phone chain". **Presque Isle - Galen Weibley,** formerly of Pennsylvania was hired as Presque Isle's Director of Economic and Community Development in December, 2019. Weibley replaces **Kenneth Arndt** who retired after holding the position for two decades.

The **Piscataquis County Economic Development Council's Executive Committee voted on February 5**, 2020 to hire John Shea, replacing Christopher Winstead as Executive Director. Mr. Shea more recently served as Executive Director of the Aquidneck Island Planning Commission in Middletown, Rhode Island.

Judy East, former Executive Director of the Washington County Council of Governments, has been hired as the Executive Director of the Land Use Planning Commission (LUPC). The LUPC serves as the planning and zoning authority for the unorganized and deorganized areas of the state, including townships and plantations.

Madawaska/Edmundston International Bridge Replacement Project

Despite efforts to maintain the 100-year-old bridge connecting the Town of Madawaska with the City of Edmundston, the rate of deterioration means the bridge has reached its useful service life. In October 2017, the bridge was posted at 5 tons, the equivalent of a passenger vehicle. In May 2018, a Feasibility Study was The MaineDOT has estimated their share of funding to be \$84,600,000. They will be responsible for designing the bridge, administering contracts and overseeing construction. MaineDOT will be assisted by the New Brunswick Department of Transportation and Infrastructure. There are three pregualified bridge

completed with MaineDOT, the New Brunswick Department of Transportation and Infrastructure, and the U.S. General Services Administration. The study concluded that the substantial investments to upgrade the current bridge to meet the needs of today's communities and businesses because of width and load capacity is not cost-effective. А new



international bridge will be constructed approximately 1,300 feet upriver from its current location on the St. John River. The project is scheduled to be advertised sometime during October-December 2020 with physical construction to begin in 2021.


Twin Rivers Paper Company owns mills in Madawaska, Maine and Edmundston, New Brunswick, Canada. The Madawaska mill sits in the middle of the downtown and is located at one end of the international bridge connecting the community with the City of Edmundston. The Edmundston Twin Rivers facility is a pulp mill that

delivers bleached softwood sulphite and groundwood pulp to the Madawaska paper mill for the manufacture of specialty packaging, technical, label, and publishing papers as well as softwood lumber. Between 1975 and 1980, a high-pressure steam pipeline was constructed across the St. John River from the Edmundston facility to Madawaska to deliver the sulphite and groundwood pulp.

Town of Houlton

In February 2020, Nancy Ketch, Houlton's Community Development Director and Scott Dionne of Southern Aroostook Development Corporation collaboratively updated the Houlton Rotary Club about Houlton's Tax Increment Financing (TIF) programs. Houlton currently has three TIF Districts: Downtown, Airport Industrial Park, and North Street Zone. The Downtown TIF includes three programs:

- Downtown Revolving Loan Fund (RLF) established to encourage investments that improve the longevity of buildings, such as upgrading and improving roofing, mechanical systems, fenestration, ADA and life safety compliance. Loans of up to \$100,000 at 3% fixed interest rates for the term of the loan. The program provides gap funding with a preferred financing structure of 60-30-10 (60 from lender/banks – 30 from Downtown RLF – 10 from owner/borrower).
- This Micro Loan Program assists downtown businesses with working capital of between \$500 and \$5,000 in loans with interest rates being prime and fixed for the 5-year maximum term of the loan.



• The Funding Initiative/Façade Grant Program encourages private investment in improving historic facades in the downtown by making available grants to reimburse 50% of the total cost of the improvement project. The maximum matching grant amount is \$5,000.

U.S. Housing and Urban Development

As part of the CARES Act, the U.S. Housing and Urban Development (HUD) will allocate \$3.064 billion to the Community Development Block Grant (CDBG), Emergency Solutions Grant (ESG), and Housing Opportunities for Persons with AIDS programs. Using the existing formula for allocations of the CDBG program, the additional allocation will result in Maine receiving approximately \$7 million. The 2019 CDBG Program will be amended to receive the funds to be used for COVID-19 related issues. The distribution is as follows:

- \$2 billion to help states, communities, and non-profits construct medical facilities for testing and treatment and acquire hotel/motel buildings to expand hospital capacity;
- > \$1 billion to keep America's Homeless Citizens safe; and
- > \$63.7 million to help Americans with compromised immune systems

The additional allocation cuts red tape to allow for targeting funding for COVID-19 response

2020 CENSUS

The U.S. Census 2020 will be the 24th U.S. Census. This is the first U.S. Census to offer options to respond online or by phone in addition to the paper form as with previous censuses.

WHY ARE CENSUS SURVEYS IMPORTANT!

Census information helps determine how billions of federal funding will be distributed to states and communities. Census results determine how many seats in Congress each state gets. And responding to census surveys is mandated by the U.S. Constitution.

IMPORTANT DATES TO REMEMBER!

 Mid-March – Invitations to complete the 2020 Census will be sent out

Three ways you can respond!





- March 30-April 1 Count of people in homeless shelters, soup kitchens, mobile food vans, on the streets, and at outdoor locations
- ✓ April Census takers will visit college students living on campus, people living in senior centers, and other people living among large groups
- May-July Census takers will visit homes that haven't responded to the March invitation
- ✓ December Census Bureau will deliver apportionment counts to the President and Congress
- March 31, 2021 Census Bureau will send redistricting counts to states. This information is used to redraw legislative districts based on population changes.

News from the 129th Legislature Second Regular Session

A March 2020 Revenue Forecast by the Consensus Economic Forecasting Commission was presented to the 129th Legislature and Governor Mills. To summarize -

- The General Fund revenue estimates were revised upward by \$40.0 million for FY2020 and \$34.1 million for FY2021.
- The Highway Fund revenue estimates were also revised upward by \$0.9 million for FY2020 but \$83,605 decrease in FY2021.
- The Fund for a Healthy Maine estimates is projected to increase by \$73,576 in FY2020.
- Medicaid/MaineCare Dedicated Revenue taxes are revised upward by \$1.1 million for FY2020 and \$1.1 million for FY2021.

While the Commission did discuss the potential for economic impacts from COVID-19, it did not make specific modifications to its economic forecast.

- USDA Rural Development Rural Energy Savings Program: Applications for energy savings will be
 accepted in a two-step process. Step 1 is a Letter of Interest that is immediately being accepted by USDA and
 Step 2 is a full application, which is due 90 days from the date USDA approves the Letter of Intent.
- USDA Section 533 Housing Preservation Grant: This is a grant program that provides funding to low and very low-income homeowners with repair or replacement of homes. The deadline for application is May 7, 2020
- **Community Food Projects Program:** Designed to meet the food needs of low-income households. The application deadline is June 3, 2020
- Maine Community Foundation:
 - Belvedere Historic Preservation and Energy Efficiency Grant Program Preservation and restoration of historic buildings. Application deadline is June 1
