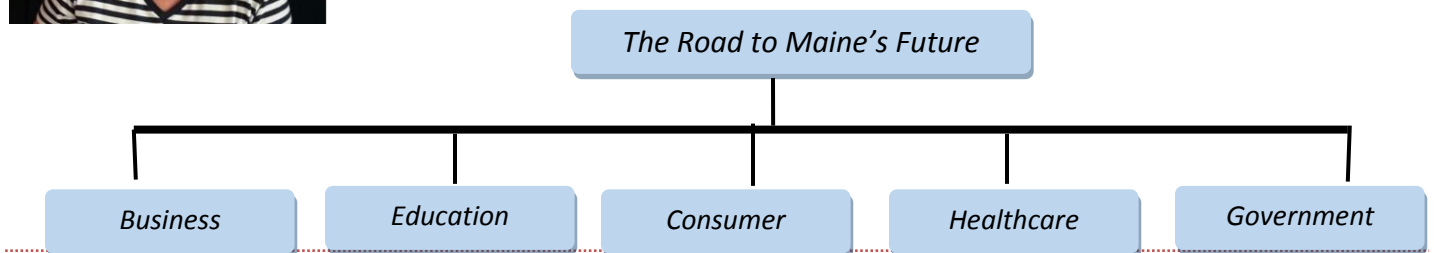
MCDA ANNUAL MEETING

Following the election of officers, awards presentation, and a business meeting, Lisa Leahy of ConnectME Authority of Maine was this year's Guest Speaker. Since 2009, Ms. Leahy has served as the Associate Executive Director of ConnectME. She is responsible for directing multiple projects to advance broadband throughout the state of Maine and manages a multi-million dollar broadband grant program. Broadband is described as "*The Road to Maine's Future*" as it serves business, education, consumer, healthcare, and government.



The ConnectME Authority is a component unit of Maine state government whose mission is to facilitate the universal availability of broadband to all Mainers and help them understand the valuable role it can play in enriching their lives and helping their communities and businesses thrive.

The internet is a vital connection to the world economy. Maine businesses use the internet to communicate with customers, stimulate new ideas, reach new markets, and create jobs. Approximately 21% of economic growth from 2004 to 2009 is attributed to the internet. Consumers use the internet for online purchases and services. Students and teachers use the internet to gain individualized, interactive and affordable education. Health care organizations use the internet to consult directly with patients. People with chronic diseases are able to monitor themselves and the use of telemedicine helps the elderly stay in their homes. Government can provide a wide range of services more effectively and less expensively reducing administrative costs and lower costs to taxpayers.

About 75% of Mainers use broadband in the home, which is about the U.S. average. But it's below other places. Similarly the percentage of connections with speeds 10 Mbps or Greater are higher in other states as compared to the State of Maine. For example, less than 10% of Maine connections have speeds 10 Mbps or greater while the State of Rhode Island has 40% or greater connections with the higher speeds.

FUNDING OPPORTUNITIES

1. CDBG Program -

The distribution of the 2016 Community Development Block Grant (CDBG) program funds are currently being allocated among several community and economic development programs. The Maine Department of Economic and Community Development (DECD) continue to accept Letters of Intent (LOI) for the economic development and micro enterprise programs. LOIs are due the first Friday of Apr, May, Jun, July, Aug, and September. LOIs for the housing assistance program is due March 11 and the Safe Neighborhood and Workforce Development programs are due May 6. To date, the following LOIs and applications have been submitted to DECD -

Funds requested far exceed the available CDBG amounts available in each program demonstrating the community and economic development needs of Maine communities. Additional information on the CDBG program can be viewed at www.meocd.org.

2. USDA - Specialty Crop Block Grant Program -

Administered by the Agricultural Marketing Service, the Specialist Crop Block Grant (SCBG) Program's purpose is to increase the competitiveness of specialty crops defined as fruits, vegetables, tree nuts, dried fruits, horticulture and nursery crops. The SCBG application is due July 6, 2016. Please contact your State Department of Agriculture Project Coordinator who is Jessica Nixon, Director of Marketing Development. 3. USDA Natural Resources Conservation Service -

The Conservation Innovation Grant (CIG) promotes environmental protection or natural resources enhancement and encompasses development. This year's focus is on water quality and conservation finance. Applications for funding are due May 10, 2016. Details on this grant program can be found at www.nrcs.usda.gov.

4. Kessler Foundation -

The Kessler Foundation is dedicated to improving the quality of life for people with disabilities through discovery, innovation, demonstration, application, and dissemination. To that end, the foundation is inviting Concept Applications from nonprofit organizations for its annual Signature Employment grants program, which supports new pilot initiatives, demonstration projects, or social ventures that lead to the generation of new ideas aimed at solving the unemployment and underemployment of individuals with disabilities. Grants up to \$500,000 over two years are available. If accepted full proposals are due by July 1, 2016.

5. Bangor Savings Bank Foundation -

The foundation supports programs designed to promote culture and arts; education; health and wellness; and social and civic services. Special emphasis is directed toward initiatives designed to increase workforce education levels and address out-migration of youth; increase regional income levels and economic activity in rural communities; and support Maine entrepreneurs and micro-enterprise businesses whose needs are not met by existing programs. Deadline for applications is April 1, 2016.

6. Rural Energy for America Program -

The Rural Energy for America Program (REAP) provides guaranteed loan financing and grant funding to agricultural producers and rural small businesses to purchase or install renewable energy systems or make energy efficiency improvements. Applications for Grants up to \$20,000 or less or unrestricted grants up to \$500,000 are due by May 2, 2016. For more information, please visit the USDA website at www.rd.usda.gov.

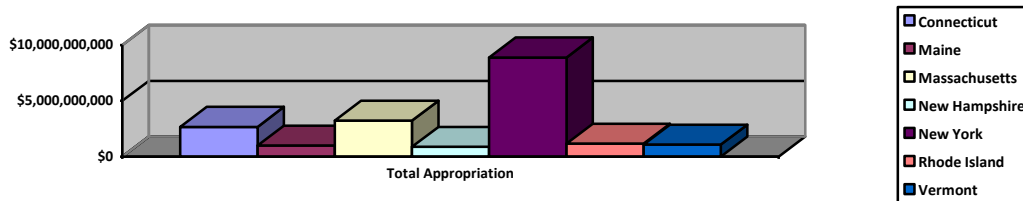


On December 4, 2015, President Obama signed into law the FAST (***Fixing America's Surface Transportation***) Act, the first federal law in over 10 years to provide long term funding for surface transportation. The FAST Act authorizes \$305 billion over fiscal years 2016-2020 for highway and public transportation. The \$305 billion will be allocated as follows:

•Federal Highway Administration	\$226.3
•Federal Transit Administration	\$ 61.1
•Federal Motor Carrier Safety Administration	\$ 3.2
•Pipeline & Hazardous Materials Administration	\$ 0.4
•National Highway Traffic Safety Administration	\$ 4.7
•Federal Railroad Administration	\$ 10.3

The Maine Municipal Association, in conjunction with six other New England states, recently submitted the 2016 Federal Issues Paper to their respective congressional delegations highlighting several issues affecting municipalities; one of which is the transportation infrastructure, which needs constant attention due to the harsh and unpredictable winters in New England. The following details the FY2016-FY2020 Total Highway and Bridge Improvements Appropriation for each of the seven New England states. The appropriation for the highway and bridge improvements is \$18.8 billion, totaling 8.3% of the \$226.3 billion for Federal Highway Administration.

FY2017 PRESIDENT'S PROPOSED BUDGET

On February 9, 2016, the FY2017 President's Budget was released describing the proposed \$4.5 trillion budget. Approximately 1/3 of the federal spending budget is apportioned for discretionary spending and 2/3 for mandatory spending (entitlements). Under the proposed budget, the following budgets would be reduced –

• Corps of Engineers	-\$1.2 billion
• FEMA Preparedness Grants	-\$460 million
• LIHEAP	-\$390 million
• EPA's Clean Water and Drinking Water State RLF	-\$257 million

New programs proposed under the FY2017 budget would include –

- \$10/barrel oil tax with revenue dedicated to infrastructure investments
- Clean Energy Research
- Cancer Research
- Investment in Computer Science Education
- Partnerships for Opportunities & Workforce and Economic Revitalization
- Interagency proposal to help communities adapt to the changing energy sector
- \$75 million in target funds toward
 - \$20M – Department of Labor's Dislocated Workers National Reserve
 - \$50 M – ARC investments in coal communities
 - \$5 M – EPA's Brownfields Program

Under the proposed FY2017 budget, the following federal agencies would be affected –

EDA Program

- Decrease of \$7 million for core programs
- Increase of \$3 million for planning grants
- Decrease of \$15 million for public works
- \$25 million for Regional Innovation Strategies
- \$50 million for a new Lab-to-Market Competitive Grant

Federal-State Regional Commissions

- Decrease of \$2.5 million from FY2016's allocation of \$7.5 million

USDA Programs

- Budget of \$2.8 billion with \$2.5 billion allocated for discretionary spending.

HUD – CDBG

- \$2.8 billion budget, a decrease of \$200 million
 - \$950 million for HOME Partnership
 - \$2.7 billion for Homeless Assistance Grants

NEWS FROM AROUND THE STATE

(Fort Fairfield) – Like many rural communities, the Town of Fort Fairfield has limited connectivity to the Internet, once you stray from the more urban sections of downtown. Many rural residents and businesses struggle to find reliable, fast Internet service, which impacts their ability to work from home, connect with friends and family, or communicate effectively with others. And like many rural communities, Fort Fairfield has limited resources with which to improve this situation without investments made by private Internet Service Providers and other partners.

In the fall of 2015, the Town conducted a door-to-door Internet Access Survey, which provided insights on existing Internet infrastructure and service. Survey results have already been provided to companies interested in upgrading the community's connectivity, and to the ConnectME Authority, a component of state government charged with helping to facilitate improvements in Maine's broadband service.

Upon learning about Fort Fairfield's efforts, the James W. Sewall Company reached out to the Town with an offer of help. Sewall, which has been helping corporate and municipal clients with engineering needs for more than 135 years, has offered to conduct a Broadband Feasibility Study for the town, free of charge, saving the municipality tens of thousands of dollars. The study is looking at the current telecommunications infrastructure, providing the Town with valuable information about options to improve Internet access and speeds, and positioning the community to seek partnerships and funding to improve broadband access throughout the community.

"This is a great opportunity for Sewall to use its resources and industry expertise to assist the people of Fort Fairfield," said Brian Lippold, Sewall's Director of Broadband and Telecom Consulting. "There is a growing realization among Maine communities that fast, reliable Internet access may not reach them as quickly as they would

like, or reach everyone in their community. By conducting a feasibility study, we can help municipalities better understand their assets and options moving forward."

The extensive study, which will take more than four months to complete, will look at every broadband option currently being deployed in the community and provide a detailed analysis of the challenges and opportunities available to address the issue.

"We just do not have the population and business base for most Internet service providers to make the necessary investments to improve connectivity in a community as large and spread-out as ours," stated Jim Risner, Fort Fairfield Town Manager. "We appreciate this generous offer from Sewall to partner with us in conducting a feasibility study, building on the project which we started, and providing us more data to make a well-informed decision as we work to improve our broadband access."

The feasibility study will assess and map current Internet infrastructure and access within the community, look at options to address substandard broadband connectivity and their associated costs, and provide the town with information to help chart a course to faster and more reliable Internet access. The study will be completed in early spring, 2016.

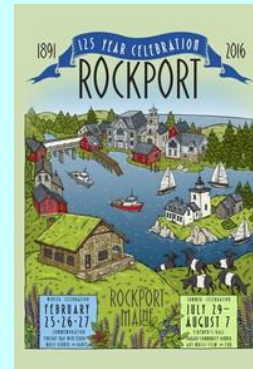
