Federal and State Investment in the Community Development Block Grant (CDBG) Program

Maine Municipal Association, along with other Northeastern U.S. States (Connecticut, Massachusetts, New Hampshire, New York, Rhode Island and Vermont) are in the process of completing the 2017 Federal Issues Paper. This year's paper focuses on three investment issues; 1) Federal funding for infrastructure¹, 2) Federal funding for the Community Development Block Grant (CDBG) Program; and 3) Preservation of tax exempt status for municipal bonds.

The goal of the Federal Issues Paper (FIP) is to provide the congressional delegation of the Northeastern U.S. states with examples of how important and valuable these federal investments are to our communities. For this reason, MMA is seeking the communities' help in providing information, such as data and examples of how municipalities across the state have used or could use federal assistance to address municipal infrastructure needs and have utilized or would like to utilize CDBG funds.


MMA is interested in obtaining this type of information as soon as possible so that it may be included in the FIP. Please submit articles to MMA either by e-mail to kdufour@memun.org or fax 624-0129. The FIP is scheduled to be printed on February 24, 2017.

At the state level, a bill sponsored by Rep. John Madigan of Rumford, LD 165 would provide an appropriation of \$3,000,000 from the State's General Fund in FY 2018 to provide municipalities with a one-time match to the Federal CDBG Program. The match would be distributed as a grant to local units of government for community projects such as infrastructure, housing, downtown revitalization, public facilities and economic development projects. The status of this bill will be updated in the upcoming newsletters.

Small Business Development Centers

Small businesses in Maine make up over 96% of businesses and are responsible for employing over 57% of the private workforce. These entrepreneurs and small business owners turn to the Maine Small Business Development Center (SBDC) each year to help with business start-ups or managing the growth of existing businesses.

The recently released 2016 SBDC Annual Report indicates that 14 certified business advisors met with approximately 1,600 clients to help start 120 businesses, create and save 1,006 jobs, and generate \$47.1 million in capital. The SBDC advisors help build and strengthen small businesses through professional business advisory, training and educational resources. The following chart depicts the industries seeking counseling.



The report also provided a breakdown of client composition in Maine as follows:

- 47.1% women
- 4.0% veterans
- 6.9% minorities

Approximately 47% of businesses seeking counseling were start-ups while the remaining 53% were counseled on growing existing business.

The Maine SBDC host organizations include the Androscoggin Valley Council of Governments (AVCOG), Coastal Enterprise, Inc. (CEI), Northern Maine Development Center (NMDC), and the University of Southern Maine (USM).

On May 13, 2016, the Maine Small Business Development Center released this statement:

The Maine Small Business Development Centers (Maine SBDC), a state-wide program that helps entrepreneurs start and grow their businesses, recognized business advisor Joshua Nadeau who received his Core Competencies Professional Certification from the New England Professional Development (NEPD) group on Wednesday, May 11, 2016.

Nadeau is a center director and certified business advisor in Caribou and has been with the Maine SBDC at the Northern Maine Development Commission for nearly a year. He provides no-cost, confidential business advising to small businesses and entrepreneurs in Aroostook County.

NEPD is a professional development collaboration of the Maine, New Hampshire, Vermont, Massachusetts, Connecticut and Rhode Island Small Business Development Center (SBDC) programs. NEPD provides a comprehensive, core knowledge training program that business

advisors must complete to receive certification. Although most advisors come to the SBDC with solid business experience and advanced degrees, this

professional development is the key to enhancing the value and quality of the services delivered to clients and stakeholders. The training required for this certification is comprised of four elements - participation in specified online technical content, a facilitated online discussion, a webinar, and, finally, an in-person intensive group session. To maintain certification, the advisor must complete a minimum of 24 hours of professional development each year.

Josh Nadeau, SBDC Business Counselor at NMDC has been providing assistance to businesses in Aroostook County interested in submitting a Community



Development Block Grant (CDBG) application for economic development and/or micro enterprise projects. The CDBG program requirement for businesses applying for economic development or micro enterprise funds are that they must have a business plan not older than 18 months and must have met with a SBDC business counselor in the three months prior to submitting an application. NMDC is a member of MCDA.

For Every Dollar Invested in the Maine SBDC, \$2.82 was returned in tax revenue.

Terry Ann Holden, Development Program Manager at the Department of Economic and Community Development Office of Community Development was presented with the Maine Development Foundation's Downtown Visionary Award. Presenting the award was Jon Edgerton, Vice President of Wright-Pierce and Senior Advisor on Maine's Downtown Center Advisory Council. Both Jon and Terry Ann serve on the Maine Downtown Center's Advisory Council and are members of the Maine Community Development Association.

Terry Ann, who is Co-Chair of the Maine Downtown Center's Advisory Council, was sponsored by Senior Advisor Jayne Palmer for her

dedication to redevelopment of downtowns. Colleagues have referred to her as a 'remarkable asset', 'rock of support', and 'deserves accolades' for her work in redeveloping downtowns with private/public partnerships.

Terry Ann contributes the success of downtown revitalization to the Four-Point Approach, a program designed to work together to build a sustainable and complete community revitalization. The Four-Points are: (1) organization; (2) Promotion; (3) Design; and (4) Business Retention and Attraction.

There are currently 10 communities that have achieved the "Main Street Maine" designation. They are Augusta, Bath, Belfast, Biddeford, Brunswick, Gardiner, Rockland, Saco, Skowhegan, and Waterville. Between 2002 and 2015, these 10 communities have created 1,541 part-time and full-time jobs, created 361 new businesses, have in excess of 284,000 volunteer hours and an investment of over \$248,000,000.

"Maine's Labor Shortage: New Mainers and Diversity"

The Maine Development Foundation and the Maine State Chamber of Commerce released the Maine's Labor Shortage: New Mainers and Diversity report in September, 2016. The report expresses the need to find people beyond our borders to meet the workforce challenges in Maine. Maine is known as the oldest and whitest in the nation. This presents a major workforce challenge as 'baby boomers' are nearing retirement age. Baby boomers are those individuals born between 1946 and 1964.

Economists note that retaining our young people will not be enough to fill the vacancies left from baby boomers who are retiring. Migration is the key to Maine's demographic future and is vital to Maine's economy. From 2006 to 2010, there were 2,711 new immigrant business owners in Maine generating a total of \$120 million in net income. This amount equates to 3.3% of the total net business income in the state.

"It's not that the new immigrants have fixed everything in the economy, but there are more businesses downtown, more lights on at night, more people in the grocery store, and more kids in school than there would be without them."

Throughout the state, business owners have repeatedly stated that finding workers is a real challenge. To offset this workforce challenge, businesses have turned to more automation and more efficient work practices. These changes require a higher level of skill and education. Businesses have turned to immigrants who bring these needed skills, knowledge, education and talent to address the workforce problem. To view the entire report, visit www.mdf.org.

Ironically, President Trump's Executive Order banning Syrian refugees, suspending all refugee admissions for the next 120 days, and blocking citizens from seven Muslim countries for 90 days is estimated to affect an estimated 20,000 refugees.

Measures of Growth, 2016

The Maine Development Foundation and Maine Economic Growth Council released its 22nd report of growth in Maine. In the report are performance indicators that influence Maine's economy, environmental and community, which include gross domestic product, per capita income, value-added per worker, employment and poverty. A brief summary of each performance indicator follows:

- **Gross Domestic Product:** While the U.S. economy grew by 9.4% from 2009 to 2014, the New England region grew by only 6.0% and the State of Maine's gross domestic product declined by 1.2%. In 2014, the industries that made up the majority of growth in the state included real estate, government, health care and social assistance, manufacturing, and retail trade.
- **Per Capita Income:** Maine's Per Capita Income trails that of the U.S. and New England states. In Maine, a large percentage of its total personal income is derived from transfer payments (Social Security, unemployment, welfare, and VA benefits). In 2015, Maine ranked 36 in personal income.
- **Value-Added Per Worker:** This is determined by the quality of our workforce, costs of doing business, and the infrastructure that supports our economy. In 2014, Maine's output per worker ranked last among the 50 states and the District of Columbia.
- **Employment:** Maine added jobs in 2010 while the state's workforce continued to decline putting pressure on the labor market. If this trend continues, the gross domestic product and per capita income growth in Maine will continue to grow at a much slower pace than that of the U.S. and New England states.
- **Poverty:** The report describes the poverty rate for 2016 to have declined in seven counties (Cumberland, Sagadahoc, Lincoln, Waldo, Hancock, Androscoggin, and Kennebec); remained steady in five counties (York, Knox, Franklin, Somerset, and Washington); and increased in four counties (Penobscot, Oxford, Piscataquis, and Aroostook).

MCDA - Annual Meeting Held at the Season's Grille and Sports Lounge in Bangor – October 6, 2016

Suzie Paradis of the Town of Madawaska and Anne Krieg of the Town of Bridgton were appointed to a 2-year term as Members at Large. Gail Chase of Kennebec Valley Council of Governments serves as President of the organization; Stephen Dyer of Ransom Environmental Consulting is the Vice President, Mathew Eddy of Kennebunk is Treasurer and Joella R. In 2010, seven concerts were held with ticket sales exceeding expectations. The City is currently negotiating and finalizing a 10-year contract for more concerts.



NEWS FROM AROUND THE STATE

(Madawaska) – The Town of Madawaska was notified on January 17, 2017 that it had achieved its “Business Friendly Community Program Certification. Commissioner George Gervais notified the Town of its achievement and DECD officials will be traveling to Madawaska to present the community with the certification as well as signs to be erected at the entrance of the community. This brings the total Business Friendly Communities to 36 throughout the state.

(Bath) – The City of Bath is requesting proposals from qualified firms or individuals to purchase and develop a vacant downtown property located at 26 Summer Street in Bath’s Historic Downtown. The site consists of .58 acres and is zoned “Downtown Commercial” (C-1) and permits a wide variety of uses with space and bulk constraints. Information on the RFP scope and proposal guidelines may be obtained by contacting Scott LaFlamme, Director of Economic Development, City of Bath, 55 Front Street, Bath, ME 04530, by calling (207) 443-8372 or by e-mailing at slaflamme@cityofbath.com. Proposals must be received by Tuesday, February 14, 2017 at 12:00 p.m.

(Bath) – Bath Housing Authority was awarded a \$214,679 grant from U.S. Housing and Urban Development’s ROSS-SC grant program. The Resident Opportunities & Self-Sufficiency – Service Coordinator (ROSS-SC) grant will be used to support a Resident Services Coordinator to connect Bath Housing tenants with services and benefits, such as community health programs, home health services, transportation, education, and other concerns related to housing.

(Bridgton) – Upgrades and expansion of the wastewater treatment facilities is currently underway. Brent Bridges of Woodard and Curran is working on options and cost estimates to be considered by town officials. The proposed expansion would increase flow by an additional 95,000 gallons per day to 126,000, increasing the potential number of users from 102 to over 400. New connections are also planned to include both residential and commercial properties.

In other news, 2018 marks the 250th celebration of the settlement of Bridgton. The planning process for the celebration has begun.

(Caribou) – Caribou City Manager, Austin Bleess, announced his departure for a similar position in Texas. Police Chief Michael Gahagan, who has been Caribou’s top law enforcement administrator for 13 years and an officer since 1973, will also serve as interim City Manager until a permanent replacement can be found.

(Penquis Community Action Program) – 2017 marks Penquis’ 50th Anniversary of empowering individuals, informing leaders, and inspiring communities. PCAP covers Penobscot, Piscataquis, and Knox Counties and assisted approximately 24,000 individuals each year with helping in meeting the basic needs of low-income individuals such as housing and heating assistance. They also offer education through the Head Start/Early Head Start Program, and provides economic opportunities for residents, such as first-time homebuyer education, matched savings programs, and small business counseling.

(Ellsworth) – Oriole Way GP, LLC received permission from the City of Ellsworth’s Code Enforcement Officer to build a planned workforce housing project consisting of 50 units. In addition, Oriole Way received a financial incentive from the Maine State Housing Authority (MSHA) in the form of a federal tax credit. The \$763,790 tax credits awarded is the second highest amount awarded by MSHA.
