Martin, President of the Maine Technology Institute (MTI) who gave us an inspiring and informative presentation of what the MTI is all about and the various programs that it operates.

MCDA Training Sessions

"A Look at Alternative Financing Mechanisms"

On Thursday, May 30, 2013, MCDA held a training session to help members look at alternative financing mechanisms for economic and community development programs were held at the Seadog Conference Center in Bangor. A total of 20 MCDA members attended this highly informative training session. The following is a brief summary of presentations:

Session 1: Regional Economic Forecasting



Bev Uhlenhake, CCIM, works in all sectors of the commercial market and has brokered a range of sales, leases, and build to suits for local and national clients. She earned her CCIM in 2008 and currently sits on several boards, including Maine Real Estate & Development Association and the Brewer Planning Board. Before joining Epstein Commercial in 2004, Bev held management and executive positions in higher education and non-profit sectors. She holds a Bachelor of Arts degree from The Ohio State University and a Masters of Science in higher education administration from Iowa State University.

The points of interest in this presentation were the Bangor Area Market Overview, Bangor in Context, and Forecasting. The fastest growing market in Bangor is in retail (mall), 2nd is office (medical), 3rd is retail (secondary), 4th is office (non-medical), and 5th is industrial. Ms. Uhlenhake described how comparing commercial real estate in square footage with a count of business expected in any municipality would provide a pull factor (sale dollars per capita compared to average state sales dollars per capita).

SAMPLE - CITY OF BANGOR

Surplus/Deficit Analysis

- Total number of businesses in municipality (Bangor has 1,860)
- Expected for municipality size of Bangor is 951
- Surplus in 909

Pull Factor (PF)

- Sales data per capita in municipality
- Compared to State of Maine data per capita
- Result:
 - o PF<1: Residents are going elsewhere for goods & services
 - o PF>1: People are coming in from outside for goods/services

Session 2: Tax Increment Financing (TIF)

Shana Cook Mueller is a member of Bernstein Shur's Municipal and Regulatory Practice Group. Her practice focuses on economic development and tax increment financing (TIF). She has extensive experience developing and amending TIF development programs for municipalities and private clients all over the State of Maine, including navigating the local and state approval process as well as negotiating credit enhancement agreements.



The TIF program is an economic development tool for municipalities. It allows municipalities to capture new property tax value. The property taxes on this new value are "TIF Revenues", which then can be used to fund a wide variety of authorized project costs. Ms. Mueller and Ms. Joan

then can be used to fund a wide variety of authorized project costs. Ms. Mueller and Ms. Joan M. Fortin, Esq., presented the TIF Clean-up Bill – LD 563. This bill would fix time issues and remove meaningless requirements. In the past, municipalities had to submit the TIF application by March 1st if they wanted DECD approval by March 31st. This bill would now give the State a couple of months to review the application. The benefits of TIFs to a municipality include job retention/creation, attract new investment, maximize tax dollars, fund infrastructure improvements, promote downtown development, leverage other sources of revenue, promote transit-oriented development, and solve environmental problems. Session 3: New Tools and Resources

The Maine Technology Institute (MTI) funds innovative technologies across the state to help accelerate commercial success and grow good jobs in Maine's seven (7) technology sectors: Biotechnology, Composites and Advanced Materials, Environmental Technologies, Forest Products and Agriculture, Information Technology, Marine Technology and Aquaculture, and Precision Manufacturing. MTI receives between \$7,000,000 and \$7,500,000 annually from state appropriations. MTI offers two categories of grants — TechStart Grant and Seed Grant — and the bulk are loans — Cluster Initiative Program, Equity Capital Investments, and Development Loans.

Guest Speaker, Robert A. Martin, President of MTI serves as director on a number of community and enterprise boards and is frequently invited to speak on topics of innovation culture, entrepreneurship, transit-oriented development, and market segmentation. He was appointed to his role at MTI by Governor Paul LePage and confirmed by the 125th Legislature in September, 2012.

John Ducette, Town Manager of Skowhegan and President of the Kennebec Valley Council of Governments (KVCOG) Board of Directors announced that KVCOG hired Roseanna (Rosie) Vanadestine of Skowhegan as its new Executive Director. HUD Consolidated Plan 2010-2014

Maine State Housing Authority (MSHA) and Department of Economic and Community Development (DECD) held public forums throughout the State of Maine in June. Public forums are required by HUD for the purpose of gathering input on available programs and Maine's housing needs. The 2010-2014 Consolidated Plan was submitted in November, 2009 with Annual Plan updates required to be submitted by November 15 each year. The Consolidated Plan sets priorities for using the Home Investment Partnership (HOME), Emergency Solutions Grant (ESG), and Community Development Block Grant (CDBG).

HOME funds target people at different income levels, defined as----->

HOME funds are used to fund the Homebuyer Program, Home Improvement Program, Rental Housing Development, Supportive Housing Development, Tenant-Based Rental Assistance and 15% of the HOME funds are set aside for community housing development organizations (CHDO).

Emergency Solutions Grant provides homeless assistance grants to emergency shelters serving people who are homeless. Homelessness remains a serious concern throughout the State with a Statewide average of 300,137 emergency shelter bednights (2012) and 26,242 domestic violence bednights (2012).

Community Development Block Grant

(CDBG): In 2012, the CDBG program provided funding to 33 communities representing 13 out of 16 counties in the State of Maine. The total award of \$7,631,887 funded public facility projects (health center, library expansion, sand/salt storage shed, etc.); public infrastructure projects (sewer/water lline replacement); housing assistance (single-family housing rehabilitation and well/septic replacements); community enterprise projects (streetscapes, business façades); public service projects (energy conservation, agricultural initiatives, secure records management); and Downtown Revitalization projects.

Ecoshel

On June 11, 2013, Governor Paul R. LePage and Ecoshel CEO Bryan Kirkey announced plans to create 78 new jobs at a manufacturing facility in Ashland for a new patented cedar shingle system. Plans include the addition of up to 10 production lines in the coming years, which would boost employment even further. At the start of production, an estimated 150 additional indirect jobs will be created.

"Not only will you bring much-needed and welcomed jobs to Ashland, but your product line will also create hundreds more indirect jobs that will have a significant economic impact on communities across Aroostook County and the State of Maine", stated Governor LePage. Mr. Kirkey praised DECD for its rapid response in assisting him to locate his company in Maine from Atlanta, Georgia. Gov. LePage's economic development team, Commissioner George Gervais and Rosaire Pelletier, Forest Products Industry Liaison, expedited a Maine Rural Development Authority (MRDA) loan for the company, assisted with site selection, and assisted with the financing process with FAME and other agencies. The company decided to build its permanent manufacturing facility in Maine to be closer to an abundant source of northern white cedar and its proximity to the nation's largest cedar shingle markets in New England.

The Town of Ashland has submitted a 2013 CDBG Economic Development Grant application for gap financing for the company. Ashland is a new member of MCDA.

CAREER PATHWAYS FOR EDUCATION, CAREER AND LIFE SUCCESS

L.D. 1780 An Act to Enhance Career Pathways for Adult Learners was enacted in March, 2012. The purpose of Career Pathways is to offer a system of support that will make it easier for adults to complete their postsecondary training and education and earn the credentials that will improve their employability, increase their security, and boost their earning power. Career Pathways is defined as follows:

"Career pathways services" means career counseling and education for individuals who seek to secure employment and to advance over time to successively higher levels of education and employment by following a pathway, each step of which is designed to prepare the individual for the next level of education or employment.

Career Pathways takes a systematic approach to education, training, and employment by aligning programs and services across the workforce, education, human service, and economic development systems to support unemployed adults. The Career Pathways Toolkit: Six Key Elements for Success provides a clear sequence of education or training credentials –

- 1. Build Across-agency partnerships and clarify roles
- 2. Identify industry sector and engage employers
- 3. Design education and training programs
- 4. Identify funding needs and sources
- 5. Align policies and programs
- 6. Measure system change and performance

The Pathways Planning Process began in December, 2012 with the presentation of webinars, technical assistance from the Maine Department of Education's Adult Education representative, face-to-face symposium on developing Pathways Plan, and development of a draft plan. There are 491 municipalities in the State of Maine, yet there are only 22 municipalities who are members of the Maine Community Development Association (MCDA). Now, more than ever, MCDA urges each municipality to become a member of the organization. MCDA is an affiliate group of the Maine Municipal Association (MMA) and as such enjoys the same status regarding lobbying. MCDA's Advocacy Role is to weigh in on proposed legislation and policies that impact community development in Maine. This organization is the "voice" of community development policy making in Maine.

Each year, prior to the distribution of Community Development Block Grant (CDBG) funds, the State Department of Economic and Community Office of Development's (DECD) Community Development (OCD) holds public hearings on the upcoming program statement. Each year, proposed changes to the CDBG program are prepared and made available during the public hearing forums. Little or no representation among municipalities is on hand to provide comments on the program changes that would have a direct affect on their communities needs.

Focus on cutting federal spending and decreasing the national debt has resulted in continual decreases of the CDBG budget over the past few years. CDBG is vitally important for Maine communities since it is the only flexible source of federal assistance available to address a wide array of rural community development needs. OCD administers the CDBG funds through an annual competition based on scoring criteria adopted in the rule-making and program statement process. OCD works collaboratively with MCDA to review proposed changes and garner support for the CDBG program. This is the time for the MCDA membership to provide feedback on the CDBG program.
