Thinking Outside CDBG

(Note: These are my opinions only and do not represent the opinions and positions of the MCDA.)

At the September 11, 2012 MCDA retreat in Bangor, Office of Community Development Director Deborah Johnson remarked that because of the reductions in CDBG program funding municipalities can no longer solely depend on CDBG funding for the entire cost of a project, but must include other funding resources as well. Fortunately the membership has long recognized this and in doing so has shifted its focus from one predominate project funding source to multiple-resources. In addition to reduced funding there has also been a shift in emphasis from community to economic development. In regards to this shift in focus, I can only presume that there are members like myself who are in the process of digesting this swing and grappling with how best to utilize the changes for the benefit of the communities we serve; this is particularly true of the newly minted Workforce Development Grant Program.

In summary, as a result the recent promulgated CDBG shifts and changes MCDA as an organization is perhaps now even more critical as we try to sort these things out and adapt to the new realities.

^{*}The Housing and Economic Recovery Act became public law on July 30, 2008. The law was established as an emergency assistance for the redevelopment of abandoned and foreclosed homes and is administered through the U.S. Housing and Urban Development (HUD).

Workforce Development

The loss of manufacturing jobs has been a trend throughout the country as production shifted to countries where labor and other costs are far less. Manufacturing jobs provided well-paying jobs. Paper mill jobs, for example, were a great

source of good-paying jobs for the non-college population, noted Glenn Mills, director of economic research for the Maine Center for Workforce Research and Information. As those jobs declined, these workers were not able to find jobs that pay comparable wages. Table 1 below compares annual payroll for manufacturing between 2005 and 2010. Table 2 details the number of establishments and employees by county for the same time period. Approximately 220 establishments have been lost resulting in the loss of almost 10,000 employees.

Because of foreign competition and technology-driven jobs, the manufacturing workforce will need to become better educated. Maine's manufacturers need access to a more skilled workforce. Other in-demand jobs requiring a skilled workforce include the health-related field, network systems and data communications.

The China Toll

China entered the World Trade Organization (WTO) in 2001. Since that time, the trade deficit has resulted in the elimination and/or displacement of 2.7 million jobs. 76.9% of these jobs were in manufacturing. The China Toll on Maine was the loss of 10,000 jobs.

In 2011, China exported \$398.5 billion to the U.S. and the U.S. exported only \$96.9 billion to China.

The 2013 CDBG Proposed Program has added a new program to address community and business resource needs by providing funding for operating expenses, equipment, and program materials known as the Workforce Development Grant Program. The proposed program will provide a maximum of \$100,000 in grant funding. Communities interested in submitting an application to the Department of Economic and Community Development (DECD) for workforce development should submit a Letter of Intent, which is due on the first Friday of each month. Welcome Roxanne Eflin, **Senior** Program Director, of the Maine Downtown Center. The Maine Downtown Center (MDC) was established in 1999 to advance preservation-based economic development in Maine downtowns.

Welcome back to the Town of Madison who joined MCDA in September. Madison is known as the Gateway to the Western Mountains. Historically known as a mill town with paper, woolens, and other manufacturing as the primary employment in the community; today the Madison Business Gateway provides new opportunities for its citizens to diversify the local economy. Developed in March 27, 2000 to attract new businesses, this multi-purpose business park offers low-cost, dependable power to 57 buildable acres, fully serviced by underground utilities, including water, sewer, electricity, and fiber optic cable. A major business located in the park is Backyard Farms, which grows vine-ripened, hydroponic tomoatoes in their 24-acre greenhouse. The greenhouse incorporates grow-lights, thermal blanketing for production climate control and a water recycling runoff system. Roof runoff provides approximately 90% of irrigation water.

The Madison Economic Development Department is currently busy working on its Downtown Plan, which was adopted by the voters in 2011.

The Center is currently working with 10 Main Street Maine and 20 Maine Downtown Network communities, representing every county in Maine. The Maine Downtown Center serves as Maine's state coordinator for the National Trust for Historic Preservation's Main Street Program.

The Center is supported with private and public funds, including the Community Development Block Grant (CDBG) Program. For a number of years, MDC has relied on annual CDBG grants for a significant portion of MDC's annual revenue. The elimination of the MDC funding under the 2013 CDBG proposed program statement, will likely imperil MDC's continued ability to deliver the downtown revitalization program.

The USDA Natural Resources Conservation Service awarded the Maine Rural Partners a \$40,000 grant to carry out a heat pump demonstration project. Through the grant, Maine Rural Partners will demonstrate and evaluate an air-to-air ductless heat pump in an agricultural-based application. The Aroostook Band of Micmacs will be the recipient of the heat pump. It will be installed in the retail farm store and processing facility of Micmac Farms and Trading Company. By selecting a northern Maine site, all Maine farms will know if this technology might work for them.

Fall July to September 2012 MCDA Newsletter: Community Development Bytes 'N Pieces, Rodney Lynch, AICP

Micki Sumpter, the Ellsworth Chamber of Commerce executive director for 15 years, has been hired by the City of Ellsworth as its full-time economic development director, the first in 2½ years. She has been working part-time for the city since late 2010, when the previous director, Janet Troth, resigned.

Shannon Haines plans to resign in the fall as executive director of Waterville Main Street after nine years on the job. Haines, who worked 10- and 12-hour days and usually on weekends as well, said she thinks a change in leadership at Waterville Main Street, will be a good thing.

Jason Bird has been hired by the City of Bangor. He will be working on Bangor's downtown development. He will be the primary coordinator for its CDBG entitlement community funds as well as Business Development Officer/Downtown Coordinator. Previously he was Senior Program Director for MCEDD.

Mike Bush has left Penquis CAP for the position of Housing Director with the Penobscot Indian Nation. According to Mike the Nation has about 100 rental units they manage and they plan to add more housing. There is a staff of 6-7, and a 1+ million budget. Prior to working for Penquis CAP, Mike was along time employee of the Eastern Maine Development Corporation. He is a graduate of the University of Maine at Orono. Wishing you the best of success in your new position and your continued membership in MCDA.

Mike Baran former Director of the Office of Community Development is presently employed as Housing Inspector for Maine Housing Authority.

South Portland's Director of Economic Development *Erik Carson* has resigned from his position as the City's economic development administrator. Erik formerly held a similar position with the City of Westbrook and prior to that position was a senior planner with the State Planning Office.

MCDA RETREAT

The Maine Community Development Association (MCDA) held a retreat on Tuesday, September 11, 2012 at the Seadog Brewing Company and Conference Center in Bangor to review the proposed 2013 CDBG Program Statement and held a discussion among the MCDA membership and the Department of Economic and Community Development's (DECD) Office of Community Development Staff.

The following are comments agreed upon by the membership.

Overall Program Statement: Philosophically the 2013 CDBG Program Statement is a fundamental departure from the previous community development program whether this involves the shift from an emphasis on infrastructure to economic development or the defunding of Public Facilities. The demand for non-emergency public facilities including historic preservation, solid waste, recreation, removal of architectural barriers, libraries, day cares, and other community facilities remains very high, with the number of applications exceeding the available funds by millions of dollars every year. There is a continuing need for public support for public facilities that will not be met by redirecting CDBG funds to economic development. In summary, many Maine towns faced with rising educational and municipal services costs, combined with a limited property tax base, need CDBG funding; particularly, for public facilities.

Public Facilities

 Priority funding category if funding becomes available through the redistribution of undistributed funds

<u>Maine Downtown Center:</u> Reinstate \$100,000 for funding for the Maine Downtown Center with the funding to come from the Workforce Development category.

<u>Workforce Development:</u> Reallocate \$100,000 in funding from Workforce Development to fund the Maine Downtown Center.

<u>Economic Development:</u> The EDP threshold amount should be at a requirement of two jobs with a minimum of \$60,000. MCDA recognizes OCD's offer for flexibility to adjust the threshold; however, we believe the proposed \$100,000 limit may be too prohibitive for smaller size businesses.

<u>Regional Technical Assistance:</u> The reality is that even though there is a decrease in the availability of CDBG funds, this does not mean the need or workload has decreased.



There are 41 MCDA members located throughout the State of Maine. Membership is divided among municipalities, firms and individuals who are interested in increasing awareness and fostering communication relating to community development issues and concerns.

MCDA works closely with the staff of the Office of Community Development to offer comments on the CDBG Program. In addition to the CDBG Program, MCDA members are made up of experienced professionals with connections to other funding sources. MCDA offers training and educational workshop on a variety of community and economic development topics as well as planning and conducting low-to-moderate income (LMI) surveys.

MCDA members, town officials, economic and community development directors, planners, and other interested parties should plan on attending the 2013 CDBG Proposed Program Statement public hearing to be held on Wednesday, October 10, 2012 at DECD Office in Augusta. There are 491 municipalities in the State of Maine, yet there are only 17 municipalities who are members of the Maine Community Development Association (MCDA). Now, more than ever, MCDA urges each municipality to become a member of the organization. MCDA is an affiliate group of the Maine Municipal Association (MMA) and as such enjoys the same status regarding lobbying. MCDA's Advocacy Role is to weigh in on proposed legislation and policies that impact community development in Maine. This organization is the "voice" of community development policy making in Maine.

Each year, prior to the distribution of Community Development Block Grant (CDBG) funds, the State Department of Economic and Community Development's (DECD) Office of Community Development (OCD) holds public hearings on the upcoming program statement. Each year, proposed changes to the CDBG program are prepared and made available during the public hearing forums. Little or no representation among municipalities is on hand to provide comments on the program changes that would have a direct affect on their communities needs.

Focus on cutting federal spending and decreasing the national debt has resulted in continual decreases of the CDBG budget over the past few years. CDBG is vitally important for Maine communities since it is the only flexible source of federal assistance available to address a wide array of rural community development needs. OCD administers the CDBG funds through an annual competition based on scoring criteria adopted in the rule-making and program statement process. OCD works collaboratively with MCDA to review proposed changes and garner support for the CDBG program. This is the time for the MCDA membership to provide feedback on the CDBG program.
