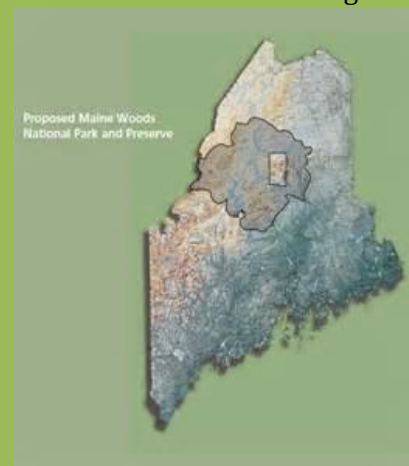
National Park Proposal

The proposed 150,000 acre national park and recreation area has been the topic of debate for nearly two years. Proponents of the proposal cite the generation of 400-1,000 new jobs, \$40 million in private endowments to maintain the park, and innovate diversification of the region's economy, mostly in the Katahdin region. The park would be located east of Baxter State Park and north of the Millinocket area. Nearly 200 tourism-related businesses have endorsed this proposal.

Opponents do not want to see this plan realized. The Maine Woods Coalition and the snowmobile association have created a list of 224 businesses, directly employing more than 39,000 people, which are opposed to the park proposal. Most of the businesses include some of the biggest logging, papermaking, forestry, land management and trucking companies in the state. Park opponents fear a park would bring federal authority to Maine, generate low-paying jobs, and restrict the state's forest products industry.

The debate over a national park in Maine has been on-going for over a decade and will most likely continue to be debated in future years. Similarly, a proposed mining operation in northern Maine has resulted in fiery debates over economic benefits versus environmental impacts. The legislature has rejected a bill for a second time that would have relaxed mining laws for the proposed Bald Mountain Mining. The legislature rejected the bill based on the high risk of sulfuric acid being released in the environment and the high cost to taxpayers for cleanup.

Maine lakes support 52,000 jobs and generate about \$3.56 million annually.

He serves on many local boards and committees including Maine Municipal Association, International City/County Management Association, Maine Municipal Employee Health Trust board as well as Crown Ambulance Advisory Committee. He is a Past President of the Aroostook Municipal Association, 1st Vice President of Professional Development and Sponsorship Chair for the Maine Town and City Management Association.

On May 29, 2015, the Fort Fairfield Town Council unanimously chose **James Risner** as the new Town Manager replacing Michael Bosse. James is from Virginia. He retired after 31 years of federal service. His last position held was as a Pentagon Liaison for the Program Executive Office of Ammunition. In addition, he has 14 years' experience in municipal government have served in many capacities as town councilor, Chairman of the town planning commission, member of the town and county joint board of zoning appeals and chairman of the Rappahannock-Rapidan Regional Commission.

News from the CDBG Program –

The Office of Community Development anticipates the 2016 CDBG funding to remain at the 2015 funding level. In 2015, the CDBG allocation was as follows:

In other news, OCD staff will meet with John Butera, Gov. LePage's Senior Economic Advisor, in the upcoming weeks to review the 2016 allocations. Proposed changes in the 2016 program will be distributed to MCDA members as well as posted on the Office of Community Development's website at www.meocd.org at a later date.

Northern Border Regional Commission

On Friday, September 4, 2015, the Northern Border Regional Commission (NBRC) announced the selection of six (6) Maine projects for grant investments totaling \$1,356,000.

1. The Town of Jay will receive \$250,000 to upgrade a portion of a municipal roadway. This is part of a larger effort to encourage private investment in an adjacent quarrying operation and granite curbing plant.
2. The Old Town-Orono Fiber Corporation will also receive \$250,000 to help create a high speed fiber optic network in which numerous internet service providers can competitively offer services.
3. The Lincolnville Sewer District's \$250,000 will be utilized as part of a substantial upgrade of the District's shoreline wastewater system. The improvements will eliminate any overboard discharging of waste and help improve the water quality for Penobscot Bay's tourism recreation and clamming industries.
4. The Town of Kingfield's application was approved for \$247,000 and will partially fund upgrades to the municipality's aging wastewater pump stations. The upgrades

will ensure property utility service to the Town's expanding downtown businesses.

5. The City of Presque Isle was awarded \$250,000 to construct improvements to a municipally-owned building that will accommodate a product line expansion for Acme Monaco, a long time Aroostook County manufacturer of surgical staples and medical guidewires. The company has indicated that moving to the new building will result in the retaining of 72 existing jobs while creating 23 new jobs.
6. The Town of Greenville will utilize \$109,000 for energy efficiency upgrades to a 11,000 square foot municipally-owned building that it leases to GlacierWear, a manufacturer of fur products that is a preferred provider to film makers and moves production companies nationwide. The lower energy costs will assist the company in creating an additional 10 jobs over the next two years.

The City of Presque Isle is an MCDA member. Congratulations to the City and all other five towns. The NBRC was created by the U.S. Congress in 2008. It is a federal-state partnership whose mission is to help alleviate economic distress and encourage private sector job creation throughout portions of Maine, New Hampshire, Vermont, and New York.

Measures of Growth 2015

On April 15, 2015, the Maine Economic Growth Council presented its annual “Measures of Growth 2015” report. The report looks at a variety of indicators to determine how Maine’s economy is doing. There are 27 performance indicators that influence the State’s economy, environment, and community. Since last year, Maine has made progress in four indicators – Cost of Doing Business, Cost of Energy, Air Quality and Water Quality; lost progress on 7; and no change on 12. The report highlights five indicators needing attention. They are Wellness and Prevention, Research and Development, High Speed Internet, Transportation Infrastructure, and 4th Grade Reading Scores. Examples of areas needing attention would include ;

- Bringing more people into Maine’s workforce is critical to the State’s economy
- Health care costs remain a concern for Maine people and business
- Maine is falling short on road improvements
- Maine Women’s earnings lose ground relative to Men’s earnings
- Nearly 2/3 of Maine adults are at unhealthy weights

The good news is that Maine’s electricity prices are lowest in a decade although prices are still above the national average. Maine is heavily reliant on petroleum products, but continued diversification of other energy sources such as natural gas, pellet, wind, tidal, and biomass gives Maine people more options to adjust to changing market conditions. It is anticipated that Maine’s retail and industrial electricity prices will decline to the U.S. average by 2020.

Another positive indicator is that of housing affordability. Housing affordability is an important factor in Maine’s economy and quality of life of Maine people. When housing is affordable, people have more disposable income to spend on other goods and services.
