## MCDA President's Message

(The following letter was presented and read to the Legislature by MCDA Vice President Darryl Sterling in support of LD 1172 funding for the Maine Downtown Center)

Joint Select Committee on Maine's Workforce and Economic Future Re: LD 1172 An Act to Support the Maine Downtown Center

Part of the mission of the Maine Community Development Association (MCDA) is to provide a statewide forum in which to increase awareness and foster communications relating to community development issues and concerns. At the recent April 12, 2013 meeting of the Maine Community Development Association (MCDA), the participating membership voted to authorize the Association's President to prepare a letter of support and that the President, or his designee, attend the hearing on MCDA's behalf to give verbal support for the appropriation to the Downtown Center. Since its inception in 1999 Maine towns and cities and individual MCDA members have used the Center's Four-Points Approach to downtown renaissance of Organization, Promotion, Design and Economic Restructuring as the basis for the numerous downtown revitalization projects around the state. In addition to providing a cohesive framework for comprehensive downtown revitalization, the Center has been at the forefront of convincing sometimes skeptical and reluctant municipal officials that downtowns are a community's only constant and sustainable business and job creator and therefore must be preserved and enhanced. Their success in this endeavor is evidenced by the fact that there is today hardly a municipal officer who is not a strong community voice for downtown and village revitalization. Taking this away would be a setback for future downtown economic rejuvenation efforts.

In summary, MCDA members live and/or work in the following nationally designated Main Street Maine or Maine Downtown Network Communities and thus experience on a daily basis the positive visual and economic development impact the Center has had on these towns and cities: Bath, Belfast, Gardiner, Sanford, Houlton, Van Buren, Madawaska, Augusta, Presque Isle, Waterville, Skowhegan, Calais, Rockland and Kingfield.

## SEQUESTRATION

(A series of automatic, across-the-board cuts to government agencies, totaling \$1.2 trillion over 10 years.

The cuts are split 50/50 between defense and domestic discretionary spending.)

Sequestration is the result of a 2011 of a shared bi-partisan arrangement between Congress and the Obama Administration to slow down the growth of the U.S. national debt, which rose to more than \$16 trillion during the recession. The Republicans and Democrats in Congress demanded spending cuts in exchange for giving the administration the opportunity to pay the federal government's obligations to its bondholder. The President acquiescesed by signing the sequester executive order where the Congress and the White House agreed to more than \$2 trillion in spending cuts with \$1 trillion for the debt-ceiling bill and the rest imposed through sequestration.

- Approximately 5,500 civilian employees, most of which work at Portsmouth Naval Shipyard in Kittery, as well as employees of the Maine Army and Air National Guard and the U.S. Army.
- 600 civilian employees at the Defense Finance and Accounting Service (DFAS) Facility in Limestone, which are scheduled to be furloughed one day per week beginning in April through September. This would result in a 20% reduction in pay for furloughed civilian employees.
- The Maine Department of Defense, Veterans, and Emergency Management employees would also furlough approximately 570 civilians working on payroll to civilians providing training.
- \$2.7 million loss for primary and secondary education (\$2.6 million for teachers and staff who work with disabled children; elimination of head start services for approximately 300 children; reduced immunization; and reduced treatment for about 800 patients with substance abuse)
- Loss of about 60 work-study jobs for Maine students.
- Loss of about \$67,000 in Justice Assistance Grants to support law enforcement, prosecution, and crime prevention.
- Loss of about \$167,000 in funding for job search assistance, referral and placement.
- Loss of nearly \$200,000 in funds that provide meals for seniors.

### Effects of Sequestration in Maine

### Jobs Forecast for 2013

Charles Colgan, former chair of Maine's Consensus Economic Forecasting Commission and a professor of public policy and management at the University of Southern Maine's Muskie School of Public Service, commented in the January 8, 2013 edition of the Bangor Daily News that Maine jobs are stuck exactly where they were four years ago. He predicts that salaried employment will increase only by 0.5% in 2013. He predicts the national economy will take 78 months to recover fully from the end of the recession (June, 2009) and that Maine's economy will take 93 months, nearly 8 years.

### Jobs Outlook to 2020

Looking forward, Maine citizens interested in pursuing high-wage, in-demand jobs should consider the Maine Department of Labor's Jobs Outlook to 2020 listing. These jobs all require post secondary education. Leading the growth rate are respiratory therapists at (41.1% growth rate over 2010); radiologic technicians (36.9%); market research analysts and marketing specialists (27.5%); health educators (24.2%); surgical technologists (24.2%); physicians and surgeons (20.0%); and actuaries (20.2%) among the top jobs. This session of the training will be based on alternative funding resources for economic and community development programs.

In addition to the program on financing there will also be a session conducted by MEREDA (Maine Real Estate and Development Association) on regional economic forecasting. The morning session will start out with a welcoming and short MCDA business meeting. So please put this on your calendar for May 30 and a registration form will be forthcoming. No cost for members and we are limited to a seating capacity of 40 persons. This is really a double feature because the next day the annual Maine Downtown Center Conference is being held in nearby Belfast and Point Lookout in Northport.

## $L.D.\ 2\overline{20}$ – An Act to Ban the United Nations Agenda 21 in Maine

In Rio de Janeiro, Brazil, in 1992, the United Nations sponsored an international conference known as the Earth Summit. The 12-day conference included formal documents signed by heads of state, including George H.W. Bush, which included Agenda 21, a document presenting detailed work plans for sustainable development. L.D. 220, sponsored by Rep. Long of Sherman seeks to ban Agenda 21. This bill prohibits the State, or any political subdivision of the State, from adopting or implementing policies originating from the United Nations Agenda 21 or other international laws that restrict private property rights without due process.

GrowSmart's Executive Director, Nancy Smith, provided testimony in opposition to L.D. 220 on March 5, 2013. GrowSmart Maine is a statewide non-profit membership-based organization working to grow Maine's economy, protect its distinctive character, and enhance the quality places that make Maine unique. Ms. Smith presented information on the Ten Principles of Smart Growth that guide effective development and planning on how Maine communities grow.

### **Ten Principles of Smart Growth**

- 1. Foster distinctive, attractive communities with a strong sense of place
- 2. Preserve open space, farmland, natural beauty, and critical environmental areas
- 3. Strengthen and direct development towards existing communities
- 4. Encourage community and stakeholder collaboration in development decisions
- 5. Make development decisions predictable, fair, and cost effective
- 6. Create a range of housing opportunities and choices
- 7. Create walkable neighborhoods8. Take advantage of compact building design9. Mix land uses
- 10. Provide a variety of transportation choices


## MCDA Welcomes New Member – Town of Fort Kent

## DID YOU KNOW!!!!!!!!

There are 491 municipalities in the State of Maine, yet there are only 22 municipalities who are members of the Maine Community Development Association (MCDA). Now, more than ever, MCDA urges each municipality to become a member of the organization. MCDA is an affiliate group of the Maine Municipal Association (MMA) and as such enjoys the same status regarding lobbying. MCDA's Advocacy Role is to weigh in on proposed legislation and policies that impact community development in Maine. This organization is the "voice" of community development policy making in Maine.

Each year, prior to the distribution of Community Development Block Grant (CDBG) funds, the State Department of Economic and Community Development's (DECD) Office of Community Development (OCD) holds public hearings on the upcoming program statement. Each year, proposed changes to the CDBG program are prepared and made available during the public hearing forums. Little or no representation among municipalities is on hand to provide comments on the program changes that would have a direct affect on their communities needs.

Focus on cutting federal spending and decreasing the national debt has resulted in continual decreases of the CDBG budget over the past few years. CDBG is vitally important for Maine communities since it is the only flexible source of federal assistance available to address a wide array of rural community development needs. OCD administers the CDBG funds through an annual competition based on scoring criteria adopted in the rule-making and program statement process. OCD works collaboratively with MCDA to review proposed changes and garner support for the CDBG program. This is the time for the MCDA membership to provide feedback on the CDBG program.
